Article 1 - Definitions

In these Terms and Conditions, the following definitions apply:

- "Gallery" refers to Unframed Art Gallery, the natural person or corporation offering art products for sale.
- "Consumer" refers to the natural person not acting on behalf of a company or profession, entering a distance agreement with the Gallery.
- "Artwork" refers to unique paintings created by graffiti artists, offered for sale by the Gallery.
- "Day" refers to a calendar day.

Article 3 - Applicability

- 1. These general terms and conditions apply to all offers and agreements between the Gallery and the consumer.
- 2. The consumer will be provided with these terms and conditions prior to concluding a distance agreement. If not reasonably possible, the consumer will be informed of the terms' availability and provided with a copy upon request.

Article 4 - Offer

- 1. All offers by the Gallery are non-binding and subject to availability.
- 2. Each offer includes clear information about the Artwork, pricing, delivery costs, and payment methods.
- 3. The Gallery ensures that the images and descriptions of the Artworks are accurate representations.

Article 5 - Agreement

- 1. The agreement is concluded when the consumer accepts the offer and meets any specified conditions.
- 2. The consumer will receive an electronic confirmation upon agreement acceptance.

Article 6 - Right of Withdrawal

- 1. The consumer has the right to withdraw from the agreement within 14 days of receiving the Artwork.
- 2. The consumer must handle the Artwork carefully during the withdrawal period and may only unpack or use it to assess whether to keep it.
- 3. To execute the right of withdrawal, the consumer must follow the Gallery's provided instructions.

Article 7 - Withdrawal Costs

- 1. If the consumer exercises the right of withdrawal, they will be responsible for returning the Artwork.
- 2. The Gallery will refund the purchase amount within 14 days after the Artwork is returned.

Article 8 - Exclusion Right of Withdrawal

1. The right of withdrawal does not apply to custom-made Artworks or Artworks that are unfit for return due to their nature.

Article 9 - Pricing

- 1. All prices are inclusive of taxes and any other applicable charges.
- 2. Prices may vary for international shipping based on location and size of the Artwork.

Article 10 - Delivery

- 1. The Gallery will make every effort to deliver Artworks within 30 days of order confirmation.
- 2. Delivery costs will be clearly indicated during the ordering process.
- 3. The risk of damage or loss of Artworks rests with the Gallery until delivery to the consumer.
- 4. If an Artwork is damaged upon receipt, the consumer must notify the Gallery within three days via email at info@unframed-art-gallery.com.
